

This practical approach helps law students with common problems and dilemmas: substitutions for "legalese" lists of commonly used legal idioms, spelling tips, advice on organization and the legal writing process, proofreading, and document design. Modeled after handbooks used at the undergraduate level, the Handbook features a small trim size, comb-binding, clear organization, two-color printing, and helpful design elements to highlight important information. Distinctive features designed with the student in mind include Websites for each topic addressed, Tips and Strategies to highlight key topics, and Challenge Exercises in each chapter to test mastery.
