The book was excellently written by three talented authors $\tilde{A}f\hat{A}\phi\tilde{A}\hat{a} \neg \tilde{A}\hat{a} \infty$ Boyce and his wife Cait and Vince Font. It was, as everyone seems to agree, almost impossible to put down. My review is written with some bit of prejudicial insight, as I grew up with both Boyce and Lee and I have practiced criminal law for well over 35 years. I had heard about the book from many people and put off reading it because I had my own version of memories - admiration for the Boyce I remember from school and well, something far less than admiration for Lee. I was not certain what to expect when I saw that there were three authors, but the book came alive for me through their words, the weave of past and present and the emotions bared raw by Chris and Cait. How hard must it have been to relive those memories!. I for one, and I'm sure there are many more, don't really care to read anything further on Daulton. I believe, after reading Cait's chapters regarding Daulton, she was overly-polite and took kindness to a whole new level. What's the old saying, the high road? She took it. Daulton Lee was and remains, a quick buck man who would trade his own mother for a starring role. Daulton did walk free from prison and I can tell you as an attorney, had it not been for Ms. Boyce, this would not have happened. She did not merely "put together a resume", this woman wrote an entire story line and presented it to a sentencing judge who despised Lee. This is no easy fete and just reading LeeÃf¢Ã ⠬à â,,¢s accomplishments in prison was never going to be enough to sway Kelleher. I argued many cases before the Honorable Robert Kelleher and, from experience, can tell you that he was no push-over. American Sons tells a brief story of Cait Mills representing an inmate at Termial Island FCI and I could not stop laughing! I had the pleasure of meeting Ms. Boyce one time back in 1990 (long before she married Boyce). The woman that I met (at TI in San Pedro) was educated,

affable, smart and sharp beyond most levels of sharpness and she had a great sense of humor (not to mention being really pretty - this is what caused me to look). I remember her as a woman who was completely and utterly dedicated to each individual inmate that she represented. On this particular day (and maybe she will remember me if she reads this) she was at TI to represent two inmates at their hearings and I was there with my client. It was hard to miss her, tall and willowy with red hair. She was really beautiful both outside and, as I learned through the day, inside as well. While I was not allowed to be in on her presentation before the Board, I know that both of her inmate clients were over the moon happy about her representation of them. We all sat in the same room waiting for the parole decisions by the Board. One by one, we were called in to hear the results - I had failed in my bid for my client and she had been successful in both of hers. I remember that she was emotional when she congratulated her clients on their freedom. I remember it because it's such a rare occurrence in my line of work to feel compassion for the people you represent. Later I heard from my client that one of her clients said that she was the only way out of prison. I think he may have been right and certainly was right in the case of Boyce and Lee. It is my fervent hope that this book makes its way to Hollywood because, while a lot has been said and written about Christopher Boyce and Andrew Daulton Lee, a smart producer should put the focus where it belongs $\tilde{A}f\hat{A}\phi\tilde{A}$ $\hat{a} \neg \tilde{A}$ $\hat{a} \infty$ firmly on Cait Boyce!Buy the book, read the book and pass it on!

What a wonderful love story! Yes, I know it was all about the federal prison system too, not so much about the "why" Christoper Boyce was in prison, what he did before he was in the system. The prison sentencing guidelines are not in proportion to the crime, and this is pointed out in the story. The story is about the federal prison system and how tough it is behind bars. I know I could never have done the solitude Christopher without trying to find a way to end my life. His tough, pugnacious legal aid-lawyer (now his wife) was never going to give up ... not on him, not on his partner, and definitely not on the medical issues she had to deal with. I admire them, and wish them only the best. Don't you just love it when something good comes to good people?

I'm only on the fourth chapter, but must say this is a captivating and mesmerizing story. It has it all, drama, tension, and it's a love story to boot. I've followed the saga of the Falcon and the Snowman since 1981, but it is SO refreshing to hear firsthand from those who have lived this tale tell us what it's been like from their perspective. Well written, even in the first few chapters you'd better have some Kleenex ready. When reading of Chris's Dad Charlie reading the letter that he just received from Chris, two weeks after Chris had escaped from Lompoc, that was a very emotional chapter. He

had no idea where Chris was, or if he was even alive. I cannot imagine that same scenario with my own child and the worry that must have filled his heart. I'll be blazing through the rest of it as time allows, but rest assured I will finish it soon.
