

It is a comically elaborate thicket of random and counterintuitive rules about how to cite judicial decisions, law review articles and the like. It is both grotesque and indispensable. Most student-edited law reviews, as well as most courts, law firms, and legal publishers, follow-slavishly-the complex and intricate directives laid down in the "Bluebook". "Like many of the judicial opinions and law review articles whose citation forms it dictates, the Bluebook is elaborate but not purposive. Form is prescribed for the sake of form, not of function; a large structure is built up, all unconsciously, by accre- tion; the superficial dominates the substantive. The vacuity and
