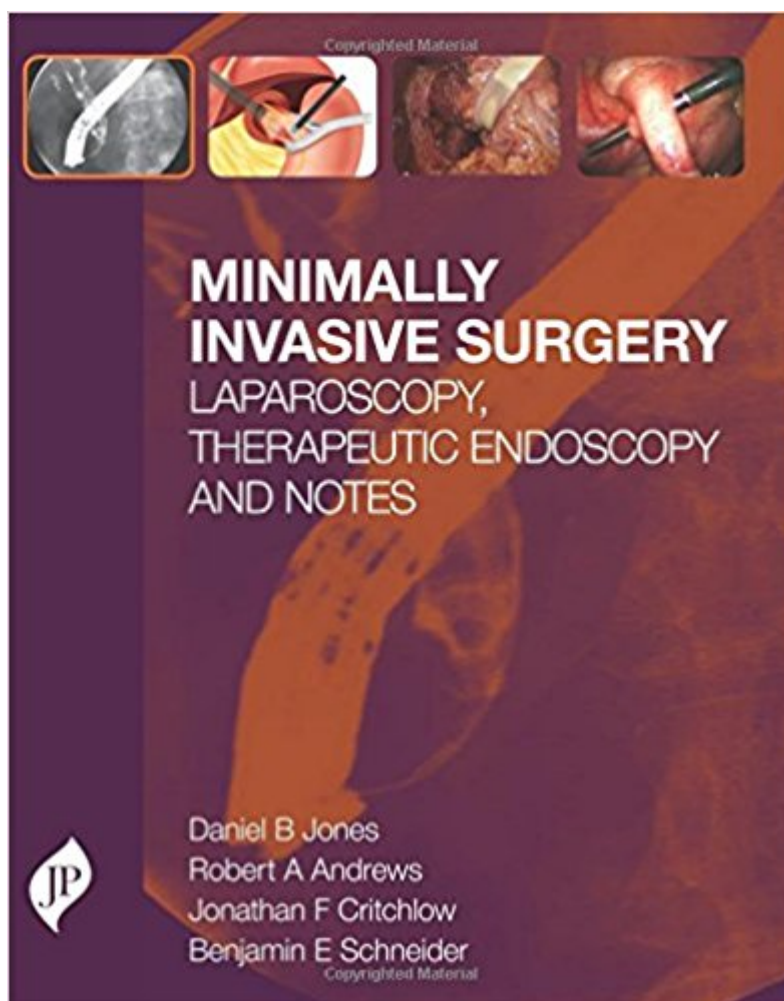

Synopsis

The book provides a comprehensive, practical review of the latest advances in minimally invasive modalities employed in general surgery. Other technique-based chapters such as obesity surgery, NOTES and advanced therapeutic endoscopy summarize the indications for use, technology, set up, techniques and pitfalls. With the use of minimally invasive techniques becoming more and more widespread, Minimally Invasive Surgery: Laparoscopy, Therapeutic Endoscopy and NOTES offers a timely review for all surgeons, gastroenterologists, residents and fellows wishing to improve the perioperative and operative care of their patients.
