

Gary B. Melton, PhD, is Professor of Psychology and Director of the Institute on Family and Neighborhood Life at Clemson University, and a fellow in the Centre for Psychology and Law at the University of the Free State in South Africa. I have an iPad and a Mac computer and the kindle app transfers those notes/highlights back and forth. At the end of the day, whether you get the electronic copy or the hardback, this book is definitely worth the cost!

I needed help with report writing (formatting, wording) and an overall crash course in dealing with the legal system from this perspective.
